I/We further understand that members of the same household may use a single Application form, but that each Applicant will be voted on separately by the Membership after completion of all requirements in force as of the date of this Application. Household members aged 5 to 16 may apply for Junior Trainer status. Membership will entitle me/us to participate in any Kuliga class without paying normal class fees. Enclosed with this Application is the non-refundable Membership Dues for the current year for each Applicant listed below. If I/we have not completed all requirements for Membership within six months of this date, this Application is void. I may reapply a second time only, within one year from original application, with no additional dues.
